NOW on this 15<sup>th</sup> day of December, 2006 this matter having been brought to the attention of the Court relative to the establishment of timeframes for case processing, the Court having reviewed the file and been otherwise fully advised on the premises, finds that such an order shall issue.


IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the following deadlines are established with respect to general trial scheduling in this case:

- a. Defendant shall within <sup>14</sup>7 days of this Order provide to the Plaintiff a copy of all information Defendant has provided to its expert witnesses.
- b. Beginning 7 days from the date of this Order, Defendant shall simultaneously provide to the Plaintiff all information it provides to its experts.
- c. By January 2, 2007, the Defendant shall file and serve on Plaintiff's Counsel a Designation of Experts, including general identification of the scope of the experts' opinions, and shall provide Counsel with CV's for any expert so designated;
- d. By February 1, 2007, Defendant shall produce to Plaintiff's Counsel any and all expert reports Defendant intends to introduce at trial, and include any documents prepared by said experts in formulating opinions;
- e. By June 1, 2007, Plaintiff's Counsel shall designate experts and provide responsive reports to Defendant's Counsel.

f. Trial in this matter is hereby set for October 29, 2007.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the following deadlines are established with respect to Defendant's pending Motion for Summary Judgment:

- a. Plaintiff's Resistance to Defendant's Motion for Summary Judgment on the issue of refunds shall be filed by February 1, 2007;
- b. Defendant's Reply, if any, shall be filed by February 15, 2007;
- c. Hearing on Defendant's Motion for Summary Judgment shall be set for February 28, 2007 at 8:15 a.m. in Room 305 of the Polk County Courthouse.
